Caterina Bonocore is an Expert on the Health opportunities in Research and Innovation programmes such as Horizon Europe (2021-2027); Evaluator for European Commission in the "Public health programme", currently named EU4healthStrong expertise on Design, Coordination, Management, Implementation of European Commission funded projects, with responsibility on leadership, coordination and quality control of international working groups, organization of working flows, resource monitoring and reporting, etc.. Public speaker, trainer and moderator in national and International conferences and workshops. Expert in stakeholder engagement, from Ministries to Associations and finding agencies.



Carla Finocchiaro has a background in Political Science and EU Law from the University of Strasbourg, France, and 30 years of experience in public research funding. She is an expert in preparing proposals for submission to the European Commission, its agencies, and other national and international funding bodies. Additionally, she has been actively providing training in grant writing and project management, particularly for groups of young researchers.



**Tonnie Rijkers** is one of the Netherlands National Contact Points for Horizon Europe Cluster 1 Health and for the Cancer Mission. She advises potential applicants on the fit of their project ideas to upcoming topics, provides feedback on draft proposals and through several formal nominations is also involved in the preparation of the upcoming Work Programmes. Tonnie has a background in (medical) biology with expertise in molecular, genetic and health-related processes, as well as in public-private collaboration in the LSH field through subsidy schemes.



**Hugo Soares** is a Science Manager at AICIB – The Portuguese Agency for Clinical Research and Biomedical Innovation – has a PhD in Biotechnology by NOVA University of Lisbon and is the co-coordinator of the European project ECHoS, aiming at Establishing Cancer Mission Hubs and to create networks of support to EU Mission on Cancer. Hugo is also the co-coordinator of the Portuguese National Cancer Hub (NCH-PT), a structure dedicated to connecting people and organizations to foster the translation of scientific evidence into policies. The NCH-PT is oriented towards the implementation of EU Mission on Cancer and EBCP initiatives in the full spectrum of cancer - from fundamental research to clinical research and clinical practice. The NCH-PT catalyses the development of multi-stakeholders' projects and connections to the community in Health, Research and beyond.
