
Nivel is an independent non-profit research institute with strong roots in primary care, patient experience measurements and health system performance assessment.

What is patient and caregiver involvement?

- Patient and public involvement (PPI):
“Research being carried out ‘with’ or ‘by’ members of the public rather than ‘to’, ‘about’ or ‘for’ them”
- Some values and principles of PPI: *respect, support, transparency,*
- Arnstein’s Ladder of Citizen Participation (1969)



Why patient and caregiver involvement?




- Some benefits of PPI include:
 - Improving relevance of research
 - Reducing ‘research waste’
 - Bringing science and society closer together
- Patients have a right to have an input to research on their condition, and reducing the knowledge gap between researchers and patients is a moral duty of researchers

How do we plan to achieve co-design?

- Handbook & checklist: Collaborations in participatory cancer research



4. Checklist

This chapter provides a checklist with important items that need to be considered before, during and after PPI activities in research. The checklist is based on Kaisler and Missbach [7] and adapted to be used in the EUonQoL project.

Before the research activities start (WP2):

- Recruitment of co-researchers
- Clear the legalities with co-researchers (e.g., usage of data)
- Set up financial compensation
- Training co-researchers (research project and research process)
- Development of contingency plan for dropouts
- Assign experienced voluntary buddies to the co-researchers for extra support and mentorship

What have we done so far?

Patient and caregiver involvement:

- Recruitment - call for action
- Selection of 5 co-researchers
- The first 2 online meetings/training sessions took place
- Connecting co-researchers to work packages based on their preferences

What will follow next?

Patient and caregiver involvement:

- Assign 'buddies' to co-researchers for extra support and mentorship
- Connect co-researchers to the work packages of EUonQoL
- Further train co-researchers for the required tasks and responsibilities (if needed)
- Formally introduce co-researchers to the work package researchers
- Organise regular support meetings with co-researchers
- Creating a strong connection between co-researchers and consortium members



Stakeholder involvement



Relevance of stakeholder involvement for the EUonQoL project:

- **Awareness and visibility of the project** among the patient, clinical, research, stakeholder and political communities is high from the outset;
- **Alignment of work** conducted within the EUonQoL and other relevant initiatives and sharing of best practices;
- EUonQoL-Kit is built in a way that **matches expectations** from both the cancer community and of wider relevant stakeholder groups.

Name of the activity	Attendees	Timelines	Focus
Pre-consensus meeting	Stakeholder Board	July	Presentation of the overall project and of the first EUonQoL draft questionnaire
Stakeholder Consensus Meeting	Stakeholder board + co-researchers + consortium partners	September	In-depth discussion of the consolidated EUonQoL draft questionnaire
Stakeholder Forum	Stakeholder board + co-researchers + consortium partners + relevant stakeholders	December	Community wide agreement on the final EUonQoL questionnaire

- Stakeholder Board composition proposed
- Pre-consensus meeting planning
- Stakeholder Forum planning

Stakeholder involvement:

- Final composition of Stakeholder Board

- Including stakeholders in consensus meetings
